## Big Pharma Lied, People Died: DeSantis Vows He'll Hold Vax Makers Accountable for Side Effects

Referencing how our powers that be are all implicated in mandating the Covid “vaccines” and thus will never expose their sometimes deadly side effects, I wrote last month that my “only hope is that a nation with a less compromised medical establishment (perhaps Sweden or Japan?) will investigate and expose the truth about the [drugs].” This may now happen, but it turns out that the place shining the light of truth will be the Sunshine State, where Governor Ron DeSantis has vowed to hold Big Pharma’s feet to the fire for false claims about its Covid gene-modification agents (GMAs, aka “vaccines”).

DeSantis made his “comments at a private Republican Party of Florida (RPOF) event at the Florida Governor’s Mansion.... He resolved to work with Florida Surgeon General Joseph Ladapo ‘to hold these manufacturers accountable,’” Florida Jolt [reports](#).

“I have Surgeon General in Florida Dr. Joseph Ladapo, who’s been really, really strong of just fighting back the narrative and the phony things that people are trying to do and focus on the evidence and so we are gonna work to hold these manufacturers accountable for this mRNA because they said there was [sic] no side effects and we know that there have been a lot,” Jolt relates DeSantis as saying.

“We did a study in Florida, and we saw an 86 percent increase in cardiac related activity in people ages 18 to 39 from mRNA shots and so we’re going to be doing some stuff to bring accountability there,” DeSantis [further stated](#). “This is something that we’re going to lead on in Florida,” he vowed, “so we’re going to have, probably, some announcements in the next three or four weeks on that.”

In June last year, [I reported on Jacob Clynick](#), a healthy 13-year-old boy who died of acute heart issues three days after his second GMA shot. Since then, such stories have only become more common, and there has been much information — suppressed by mainstream media — about cardiac problems related to the GMAs (my related personal experiences are [here](#)). In fact, Johns Hopkins professor Dr. Marty Makary just posted a relevant study to social media on Saturday (below).

This is a German study from a reputable group. It's very hard to conduct this research in the U.S.

This wouldn't surprise Steve Kirsch, executive director of the COVID-19 Early Treatment Fund. He [warned last year](#) that the government VAERS (Vaccine Adverse Event Reporting System) database "shows heart attacks happen 71 times more often following these vaccines compared to any other vaccine."

Yet can GMA manufacturers really be held accountable? The government gave them a get-out-of-lawsuits-free card, right? Not so fast. As American Greatness [writes](#):

Vaccines administered under an Emergency Use Authorization are protected from legal liability, but not if they were fraudulently produced. Brook Jackson, a whistleblower who worked for the Ventavia Research Group, the company that conducted Pfizer's pivotal phase III trial in Texas in 2020, has filed a lawsuit in U.S. District Court accusing Pfizer of committing fraud, abuse, and protocol violations in its COVID Vaccine clinical trials.

For the past year, Equity Investment Executive and former Black Rock manager Ed Dowd has been compiling evidence from the insurance industry, funeral home industry, and government databases showing that excessive deaths among working-age Americans substantially increased in 2021 over 2020. In his new book, "Cause unknown," Dowd demonstrates that non-COVID deaths among people aged 18 to 64 have exploded.

During a recent appearance on "Ask Dr. Drew," Dowd argued that the employed population in the United States (98 to 100 million people) is experiencing about a 25 percent increase in disabilities compared to the general population.

"Something is going on with our workforce," [Dowd] said, lamenting that the corporate media refuses to address what looks like a "huge problem."

This isn't the first time we've heard about this, either. Just consider the December 30, 2021 testimonial of Scott Davison, CEO of \$100-billion insurance company OneAmerica, who spoke of a historic mortality spike his industry was seeing. Note that Davison wasn't making any political point when delivering his information, either — there's no indication he's even an ideologue.

Davison [stated](#) that the mortality increase amounts to "huge, huge numbers" and that it's not elderly people dying, but "primarily working-age people 18 to 64."

"And what we saw just in third quarter, we're seeing it continue into fourth quarter, is that death rates are up 40 percent over what they were pre-pandemic," he continued.

"Just to give you an idea of how bad that is, a three-sigma or a one-in-200-year catastrophe would be 10 percent increase over pre-pandemic," Davison elaborated. "So 40 percent is just unheard of."

Now, consider: This 2021 "third quarter" age-18-to-64 death increase generally coincides with when the GMAs *were pushed on people under 65*.

As for Governor DeSantis, he's well situated to hold Big Pharma accountable and is just the man to do it. Florida experienced a historic Republican-wave election November 8, and DeSantis won reelection by a wide margin. This was after, mind you, he tackled the Velvet Mafia ("LGBTQ" crew) with a parental-rights law and another big fish, The Walt Disney Company. The latter got its wings clipped by DeSantis — who signed a bill revoking its special tax district — after the company publicly opposed the law, which helps protect children from classroom sexualization.
