What's more, the Biden administration has imported more than half a million aliens into the country as part of its parole program, <u>according to</u> a recent report from CBS News. Unsurprisingly, the CBS report lauds the administration for what it calls a "historic expansion" of legal immigration, a laughably erroneous way to describe the administration's abuse of the parole program.

Much like the more than <u>five million illegal aliens</u> who have entered the country through the southern border since Joe Biden took office, the vast majority of aliens being released through the parole program do not have legitimate asylum claims, and do not have any reason to be fast-tracked into the United States.

As the Immigration Reform Law Institute <u>made clear</u> in a recent brief to the Eleventh Circuit Court of Appeals, parole must be granted on a case-by-case basis for "urgent humanitarian reasons," or "significant public benefit," neither of which applies to the way the administration is currently employing the program. What the Biden administration has done through the use of the parole program and CBP One app is resettle historic numbers of foreign nationals into the country while avoiding negative headlines.
