



Study: WHO Data Show Surge in Covid-shot-related Heart Deaths

It's "as serious as a heart attack."

In fact, it is a heart attack — or, at least, something related to it. Unfortunately, too many people haven't taken seriously the issue of Covid-shot-related heart problems, even though evidence of their existence has been mounting for some time.

South Korean Study

And now yet another among many studies, this one analyzing official figures from the World Health Organization (WHO) global database, sounds the alarm about the threat mRNA "inoculations" pose to health.

According to [Slay news](#):

The bombshell data was made public by a team of medical research investigators who were able to unseal and probe the data as part of a major international study.

The research was led by several investigators at Kyung Hee University College of Medicine, Seoul, South Korea.

They published the results of the study in the prestigious peer-reviewed [Journal of Medical Virology](#).

The study sought to examine the worldwide burden of vaccine-associated heart failure (pericarditis and myocarditis) and the vaccines associated with these indications.

Pericarditis and myocarditis are both forms of inflammation in the heart that restrict the body's ability to pump blood.

Both conditions can cause cardiac arrest, strokes, blood clots, and

sudden death.

Pericarditis and myocarditis are both known side effects of Covid mRNA injections.

... Tapping into and extracting data in the WHO international pharmacovigilance database, the researchers were able to analyze vaccine-associated pericarditis and myocarditis ranging from 1969 to 2023.

The comprehensive study examined a total of 130 million reports.

Calculating global reporting counts, Sooji Lee, Department of Medicine at Kyung Hee University, and colleagues report odds ratios (RORs) as well as information components (ICs).

They sought to identify the cause of surging pericarditis and myocarditis across 156 countries and territories.

The results? “We identified 49 096 reports (male, n = 30 013) of vaccine-associated pericarditis and myocarditis among 73 590 reports of all-cause pericarditis and myocarditis,” the study authors [relate in their summary](#). “There has been a significant increase in reports of vaccine-related cardiac adverse events over time, with a noteworthy surge observed after 2020, attributed to cases of pericarditis associated with COVID-19 mRNA vaccines.”

Study Confirms Prior Findings

An “after 2020” explosion in deaths... We’ve heard this before. In a [virtual news conference](#) on December 30, 2021, OneAmerica insurance company CEO Scott Davison said that we are seeing “the highest death rates we have seen in the history of this business.” And “not just at OneAmerica,” he added. “The data is consistent across every player in that business.”

Davison further informed that this death wave involved working age people (18-64) and started in 2021’s “third quarter,” which roughly coincides with when the Covid shots *were pushed on people under 65*. Most of these weren’t Covid-19-induced deaths, either.

The CEO also stated that the numbers are so bad that the situation is worse than “a one-in-200-year catastrophe.”

Greatest Risk of Cardiac Effects

Returning to the South Korean study, the researchers compared the pericarditis and myocarditis risk the Covid shots pose with that of actual vaccines (mRNA drugs are a sort of gene manipulation). Smallpox vaccines posed the greatest risk, with an ROR of 73.68. This was followed by the Covid-19

mRNA shot's 37.77 ROR.

Apart from the anthrax vaccine (25.54 ROR), this risk was far greater than that of the other listed vaccines, whose RORs were in the single digits. The influenza vaccine was second-to-last at 1.87, for example.

Interestingly, a certain Covid shot — something called the “Ad5-vectored COVID-19 vaccine” — had the lowest ROR (1.40). But one might have to wonder about this figure.

It appears that this shot, [the Ad5-nCoV-S](#), was produced by [Chinese company CanSino Biologics](#) and might've mainly been used in China. This is significant because numbers on safety (and efficacy) coming from Beijing cannot be trusted.

For that matter, critics may suspect that WHO data understate Covid shots' danger as well, as such establishment entities have marketed the drugs with a religious-like fervor.

More Prevalent Among Males

The Korean researchers also related information on age and sex-specific risks. Reports “of vaccine-associated pericarditis and myocarditis were more prevalent among males and in older age groups,” they write. “The age group between 12 and 17 years exhibited significant sex disproportion” — with boys more affected. “Most of these adverse events had a short time to onset (median time: 1 day),” the researchers continue.

We've seen examples of this, too. In 2021, [Jacob Clynick](#), a previously healthy 13-year-old boy, died *three days after his second Covid shot*.

In fact, the same month Jacob passed, left-wing CNN [wrote about](#) “teenaged boys [who] all looked like they were having heart attacks” but were actually “suffering from a very rare type of heart inflammation” — “one that public health officials are beginning to link to Covid-19 vaccines.”

Do Kids Need the Shots?

Covid-shot defenders will claim these events are “rare.” But you know what's rarer still?

Kids dying of Covid.

One study focusing on Germany, a country of 83 million, during a 15-month, peak-pandemic period found that *not even one healthy child died of Covid*. Moreover, the CDC's own data informed years ago already that people up to age 19 have a 99.997 percent chance of surviving the disease.

In other words, there was never any reason to risk youngsters' lives by giving them the poorly tested Covid shots.

Oh, on second thought, there was one reason:

It made certain people a lot of money.

In conclusion, the aforementioned risks are why the recently launched [Hope Accord](#) has been signed by more than 5,000 scientists, academics, and medical doctors and other healthcare professionals. It demands that governments worldwide actually start saving lives — by immediately suspending Covid mRNA shots' use.
