




UN Arms Trade Treaty: Every U.S. Senator Must Be Held Accountable (Video)

For several decades now we have been warning that globalist politicians in one administration after another, as well as in Congress, have been working to disarm the American people through international agreements and United Nations treaties. For decades those warnings, which were statements of fact, were dismissed by the “progressive-minded” as paranoia. Well, the Obama administration has signed the Arms Trade Treaty and the battle now goes to the Senate.



For decades, the United Nations has been pushing an agenda for all nations of the world to disarm their peoples. Civilians — individual citizens — must not have recourse to arms, says the UN. Governments must have a monopoly on force.
