## Obama Signs On To UN Homosexual Rights

The U.S. Supreme Court has already struck down state laws that criminalized sodomy. However, the legal consequences of the UN document could extend beyond decriminalization to providing special rights to homosexuals as a victim group.

There has been consternation that the UN document would go beyond the Supreme Court decision in superseding the rights of states to govern according to their own (the people's) will. Obama wanted to sign the document to prove, says the State Department, that the United States supports human rights for all, and is in the process of notifying Congress of his intent. [State Department spokesman Robert Wood issued a statement](#) saying how pleased the United States is to join other countries in condemning "human rights violations based on sexual orientation and gender identity."

Wood added, "The United States is an outspoken defender of human rights and critic of human rights abuses around the world. As such, we join with the other supporters of this Statement and we will continue to remind countries of the importance of respecting the human rights of all people in all appropriate international fora."

The UN declaration has absolutely nothing to do with supporting human rights for all, or it would mention the lives of the unborn. It is about promoting the homosexual agenda globally. The UN would dictate to every country, regardless of its culture and religions and traditions and morals, the treatment homosexuals receive, possibly to the detriment of the rest of society.
