## Pro-pedo California Releases Child Rapists, Puts Perverts Back on the Street to Molest Again

Consistent with the radical Left's [protecting the "right"](#) of drag queens to groom children, leftist California is releasing child sex offenders in violation of sentencing guidelines.

Some of the perverts have raped kids under 14 years old.

The latest on leftist normalization of adult-child sex comes from the *Daily Mail*, which analyzed almost 55,000 cases in California's "Megan's Law" database of sex offenders, and found that the average child sex offender spent less than three years in prison.

The report comes as the radical Left increases its support for sexual deviants who publicly parade their preferences, including those who call themselves "minor-attracted persons."

### The Data

"More than 7,000 sex offenders were convicted of 'lewd or lascivious acts with a child under 14 years of age' but were let out of prison the same year they were incarcerated, data from the California Megan's Law database says," the [Mail reported](#):

Others who committed some of the worst child sex crimes on the statute books served similarly short sentences, including 365 pedophiles convicted of continuous sexual abuse of a child who spent less than 12 months in prison, 39 cases of sodomy with a child under 16, and three cases of kidnapping a child under 14 "with intent to commit lewd or lascivious acts", according to the data.

A former sex crimes prosecutor, Samuel Dordulian, told the *Mail* that parents had better be worried.

"Statistics clearly show that pedophiles don't get reformed," he said. "They're going to come out and they're going to commit again."

Continued Dordulian:

Letting these people out early, we're allowing for a lot more victimization. And that's terrifying.

The *Mail* combed the Megan's Law database of 54,986 sex offenders on the site as of July 2019, and found that 41,794 of the sex fiends, or 76 percent, went after kids.

The *Mail* “compared the published dates of these pedophiles’ convictions versus the year they were released from prison according to the Megan’s Law database.” The result: “The average pedophile served two years and 10 months in prison.”

A close look at the data suggest that parents had better hide their kids:

The most common offense in the database was “lewd or lascivious acts with a child under 14 years of age,” committed 19,441 times. Despite its severity, the average time served for this crime was just two years and 11 months.

And 7,152 pedophiles who committed this crime served less than a year.

Some 114 men who committed the even worse version of this offense, where the act against the under-14 child was “by force or fear,” ended up serving less than a year in prison, according to the data.

Others serving less than 12 months included 13 counts of aggravated sexual assault of an under-14 with intent to rape, three counts of kidnapping a child under 14 with intent to commit lewd or lascivious acts, five counts of assault with intent to rape an under-18, and two counts of pimping minors.

Dordulian told the website that the average time served is “surprisingly very low.”

“In my days [in the LA DA’s office], we made every effort to get as long of a prison sentence as we could, because we knew that the minute they’re going to come out, they’re more likely to reoffend and another child’s gonna get harmed,” he said.

## **Perverts Galore**

That raises the question of whether the only suitable punishment for a child molester is execution.

That aside, the [website also offered](#) examples of the men whom California’s leftist authorities believe belong back on the street.

Carlos Alexander Nahue, 48, was convicted of “continuous sexual abuse of a child” in 2015, but after pleading no contest, he landed in the Los Angeles County Jail for just two days. Now he lives a block away from a day care center and three blocks from an elementary school.

In 2013, pervert Noah Thomas Holt was convicted of lewd acts with a kid under 14 years old, possession of child pornography, and indecent exposure, the *Mail* reported:

The 31-year-old was convicted on a no contest plea in December 2013. But Megan’s law data says he was released within a year, and according to his Facebook page he started a new job at manufacturing company Threshold Enterprises in Scotts Valley, California in 2014.

Holt has posted several pictures with a young girl on his Facebook page. He was also convicted of a DUI in 2017.

Another of California’s fine residents is Gualterio Lopez Contreras. He “was charged in May 2014 with sodomy by use of force, sexual penetration by force, and continuous sexual abuse of a child,” the [Mail reported](#), but “pleaded no contest to one count of a lewd or lascivious act with a minor in February

2016, and was sentenced to three years in Wasco State Prison.”

He served less than a year.

“Thierry Armand Costa, 61, was convicted in 2014 of lewd acts with an under-14 and using a minor to make child porn, but was released from prison the same year,” the *Mail* reported:

His Santa Clara County court records say he was sentenced for the crimes in November 2013 but had two probation motions heard in his case in 2015. He also had a hearing to remove his records from the courts in October 2019.

[Megan’s Law](#) is a federal statute that requires authorities to release information about sex offenders to the public.

## **Pedophilia Normalized**

California’s releasing the pedophiles is not surprising.

Two years ago, the state passed a bill that would permit some pedophiles to not register as sex offenders.

“The bill, introduced by Sen. Scott Wiener 18 months ago, relaxes sex offender registry requirements for sodomy and other acts with minors to reportedly end ‘discrimination against LGBTQ young people on the sex offender registry,’ according to Wiener,” [The Center Square reported](#):

[According to the bill itself,] “This bill would exempt from mandatory registration under the act a person convicted of certain offenses involving minors if the person is not more than 10 years older than the minor and if that offense is the only one requiring the person to register.”

The bill specifically gives judges discretion over whether to make an adult register as a sex offender if they had anal or oral sex with a willing minor, and only if the minor is 14 years old or older and the statutory rapist is less than ten years older.

[A flaming homosexual](#), Wiener was also behind a bill [to soften](#) the penalty for knowingly infecting a sexual partner with AIDS. The bill made the crime, which amounts to attempted murder, a misdemeanor.

Pedo backers such as Wiener are everywhere in government, the academy, and the leftist media. [NBC permits](#) a pedo apologist to write for its website, and a pro-pedo professor, obsessed with normalizing child molesters as “minor-attracted persons,” [was forced out](#) of his job at a university in 2021.
